Whereas the Furparent wishes to engage North Metro Pet Services, LLC and North Metro Pet Services, LLC agrees to undertake the services under the terms and provisions defined in this Pet Care Contract as well as Furparent's Information (Exhibit A), Pet Information (Exhibit B), the Veterinary Release (Exhibit C) and the Services Menu (Exhibit D) which shall all become part of this Contract. Any reference to pets in this contract shall refer to those specified on the Pet Information Sheet.

DESCRIPTION OF SERVICES. NMPS will provide the following services (collectively the "Services") as outlined in the services menu (Exhibit D) prices subject to change:

Furkid Visits, Furkid Walks, Furkid Runs, Furkid Overnight/Vacation Packages, Other Services & Standard Services

PAYMENT FOR SERVICES. Payment for services is due at the time of service unless other previously agreed upon terms have been set.

Additional fees may include the purchase of necessary items for the care of the pet, including but not limited to pet food, litter or cleaning supplies, transportation, unexpected visits and emergency expenses for health care. North Metro Pet Services, LLC shall retain and submit receipts as proof of additional expense.

TERMINATION. This contract shall automatically renew every 12 months unless terminated in writing by either party.

DIGITAL MEDIA. The Furparent gives North Metro Pet Services, LLC permission to use any digital media that it creates in its marketing or digital media.

EMERGENCIES. In the event of an emergency, North Metro Pet Services, LLC shall contact the Furparent at the numbers provided on Exhibit A to confirm the Furparent's choice of action. If no approved contacts can be reached in a timely manner, North Metro Pet Services, LLC is authorized to:

- a. Transport the furkid(s) to the listed veterinarian on the attached Veterinary Release Form:
- b. Request on-site treatment from a veterinarian;
- c. Transport the pet(s) to an emergency clinic if the previous two options are not feasible.

RELATIONSHIP OF PARTIES. It is understood by the parties that NMPS is an independent contractor with respect to the Furparent, and not an employee of the Furparent. The Furparent will not provide fringe benefits, including health insurance benefits, paid vacation or any other employee benefit for the benefit of NMPS.



SECURITY. NMPS warrants to keep safe and confidential all keys, remote control entry devices, access codes and personal information of Furparent and to return same to Furparent within 48 hours of request.

INJURIES. NMPS acknowledges NMPS's obligation to obtain appropriate insurance coverage for the benefit of NMPS (and NMPS's employee's, if any). NMPS waives any rights to recovery from Furparent for any injuries that NMPS (and/or NMPS's employees) may sustain while performing services under this Agreement and that are a result of the negligence of NMPS or NMPS's employees.

INDEMNIFICATION. The parties agree to indemnify and hold harmless each other as well as respective employees, successors and assigns from any and all claims losses, expenses, fees including attorney fees, costs and judgments that may be asserted due to acts or omissions of a part to this Contract.

LIBAILITY. North Metro Pet Services, LLC accepts no liability for any breach of security or loss of or damage to Furparent's property if any other person has access to the property during the term of this Contract. NMPS shall not be liable for any mishap of whatsoever nature which may befall a pet or caused by a pet who has unsupervised access to the outdoors. NMPS is released from all liability related to transporting pet(s) to and from any veterinary clinic or kennel, the medical treatment of the pet(s) and the expense thereof. NMPS is released from all liability of injury to pet(s) caused by other pet(s) or animal(s) not under the control of NMPS.

ENTIRE AGREEMENT. This Contract contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written.

SEVERABILITY. If any provision of this Contract shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Contract is invalid or unenforceable, but that by limiting such provision it would be come valid and enforceable, then such provision shall be deemed to be written, construed and enforced as so limited.

APPLICABLE LAW. This Contract shall be governed by the laws of the State of Colorado.
